Payment Contract and Terms of Enrollment Agreement

1. The Reston Montessori School will provide summer camp from June 22 until August 14, 2020 from Monday – Friday. Hours are from 9:00 am to 5:30 pm. Registration is for the entire summer. Reston Montessori School will observe the July 4th holiday.
2. **Tuition will be charged to the credit card on file at the beginning of every month (i.e. July and August). Once tuition is paid, it is non-refundable regardless of changes made after the start of the session. There will be a \$50 fee for any changes made, after the contract is signed and before the start of camp until June 18, 2020. You are responsible for updating your credit card information immediately as necessary.**

3. We, the parents, agree to abide by the rules and regulations set forth by the school for the health, safety and welfare of the child such as stated in the Parents Handbook as posted and updated on our website www.restonmontessori.com
4. The school reserves the right to deny, cancel, sever or suspend a child’s enrollment if deemed in the best interest of the child or the school, such as failure to comply with the rules of the school as stated in the Reston Montessori School Parent Handbook. The school will give the parents one (1) week written notice after a conference between the parents and the director. In such a case, all tuition payments already paid are not refundable.
5. No refunds will be made for days missed due to illness or holidays.

6. Should legal action be taken against Reston Montessori School or any staff member on my child's behalf, and the school or its staff not be found "at fault", we agree to pay any attorney's fees, court fees, damages, or other costs at that Reston Montessori or its staff should incur to defend against such action.
7. We further agree to hold Reston Montessori School and its staff harmless for any liability to my child or any guardian or parent thereof because of any injury or alleged injury to my child caused by a party other than the School or its employees acting in their official capacity and within the scope of their employment.
8. We, the Parents agree to drop-off their child(ren) no earlier than the time stated in the contract for the program they are enrolled in. The Parents agree to pick up their child(ren) from school by the time stated in the contract for the program they are enrolled in. Overtime charges will be incurred at the rate of **\$4.00 per minute per child** based on the clock in the office for every minute your child(ren) remains at school past the time stated in the parent handbook for the program they are enrolled in. Late fees will be charged to your account.
9. We understand the policies and procedures set forth in the above paragraphs and are obligated to adhere to them.
